2009 was a productive year for the Mountain West chapter, as indicated by the activities in this report. A chapter committee reviewed and made suggested revisions to our bylaws, which were voted on and approved by the chapter membership. We also revised our Winberta Yao travel award guidelines, and voted to approve a chapter dues increase. The 2009 Yao travel award went to Liz Ehrnst, and the chapter donated money to the Indianapolis conference Welcome Party. The chapter's nominating committee put forward a slate of candidates, and chapter members voted on our 2010 officers. State coordinators worked to increase chapter membership, and we did indeed gain some new members. The *Mountain Ledger*, our newsletter, continues to be stellar and we have a very strong web presence with our Mountain West chapter website.

Due to chapter members' budget constraints, we held our first ever virtual chapter meeting using Elluminate in November, 2009. The meeting was very successful and we were able to conduct chapter business.

The Mountain West chapter executive committee held two meetings during 2009, one in February via conference call, and one in September via Elluminate. Chapter members met during the April 2009 ARLIS/NA conference in Indianapolis. Two 2009 online surveys of chapter membership helped determine the format of our November 2009 chapter meeting (virtual), as well determine interest in other potential projects. Vanessa Kam, the chapters liaison, provided a written update for Mountain West chapter members.
